

1. General Selection Regulation and this Schedule

- 1.1** This Schedule 2C is a schedule to the Cycling New Zealand General Selection Regulation (last updated 10 April 2024) ([General Selection Regulation](#)) for selection of the Cyclo-cross Team for the Elite, U23 and Junior categories of the 2025 UCI Cyclo-cross World Championships.
- 1.2** Both the General Selection Regulation and this Schedule apply, including that riders must be Eligible (as defined in the Regulation). Definitions used in the General Selection Regulation apply to this Schedule, unless stated otherwise. If there is any inconsistency between this Schedule and the General Selection Regulation, the General Selection Regulation will apply to the extent of any such inconsistency.

2. Selection Objectives

- 2.1.** Cycling New Zealand’s objective in selecting a Cyclo-cross Team for the 2025 UCI Cyclo-cross World Championships is to select Eligible riders who will benefit from the opportunity of competing at international level to continue their development.

3. Additional Eligibility Requirements

- 3.1.** All riders seeking selection to a Team must complete the Rider Application by providing all the information requested in the online Rider Application by the date set out in clause 5.

4. Additional Requirement

- 4.1.** It is a condition of selection that riders must fund themselves to attend and compete at the 2025 UCI Cyclo-cross World Championships and any competitions from which results or performances may be taken into account in considering their selection.

5. Selection Criteria

5.1 In considering which Eligible Elite, U23 and Junior riders satisfy the Selection Objectives (in clause 2.1):

5.1.1 **Primary Selection Criteria:** The Selection Panel will select the female and male New Zealand National Champion in U19/Junior, U23 and Elite categories at the 2025 New Zealand Cyclo-cross National Championships (10 August 2024, Christchurch), subject to available quota places at the 2025 UCI Cyclo-cross World Championships.

In the event of a combined race at the 2025 New Zealand Cyclo-cross National Championships, the winner of each age category (U19/Junior, U23 and Elite) will be eligible for selection under this primary selection criteria.

5.1.2 **Secondary Selection Criteria:**

If a rider does not meet the Primary Selection Criteria for automatic selection:

- a. the Selection Panel will consider riders for selection who finish in the top 50% of the field at a UCI Cyclo-Cross World Cup race (in the category for which a rider is seeking selection) during the performance window.
- b. if there are more Eligible riders than remaining quota spots, riders will be ranked according to their best World Cup placing during the performance window and selected in ascending order.

6. Key Timelines

The following dates apply to this Schedule, unless amended by Cycling New Zealand due to reasons out of its control.
