GaB: Comment on the presidents report along with the transformational update that had been circulated in the last week, He queried whether RTX were being kept information and noted the areas of interest to RTX are:

Governance at the Board level, additional funding, SLT Policy and procedures, roles and responsibilities, Athlete Pathways

EC advised that MO updates with SP were yet to be reconvened and advised that EC and SS have regular conversations following the Board meetings.

SS spoke to the meeting, and advised that the CNZ Board is undergoing a governance review; there are limited resources and CNZ not flush with funds, and still has to focus on meeting the HPSNZ obligations; athletes progress – is still a wait and see how it all plays out. It was noted that there has been no conversations that SS or EC have been aware of regarding the Report. SS also noted that SP, the New CEO is picking up things as he goes along, especially with the current focus being on the 2024 Olympics. He noted the report includes things that need to be done as well as what has been done.

SP spoke to the meeting and acknowledged Life members and club members and acknowledged the last 18 months has not been a pleasant for Members. He wants to work with members. Along with the inquest, there are currently 158 projects under the transformation plan. The Transformational plan is independent of CNZ, and is due to be completed in December, when it will be handed over to the board to consider.

It was also noted that for all clubs the changes the Incorporated Societies Act 1908 will have an effect and it will be timely to consider what changes need to be made to the Club constitutions – and CNZ want to work with the clubs to they are kept up to date with what is needed.
